Exhibitor Information: Dogs must be leashed or crated when not actively working. All dogs must be on leash except when in the ring! State Road 9 is a busy highway! Please pick up after your dog and dispose of waste in appropriate containers outside the building next to the Porta Potty. There will be a porta potty outside the barn. Please stay in mowed/marked areas - no dogs or humans in the surrounding fields or near the residence! Please be respectful of the resident dogs.

Trial Grounds: Trial grounds are all property of the Etchason Farm. All overnight accommodations are also considered trial grounds.

Ring Description: The ring is rubber matting on concrete with three sides of metal kennel fencing and one side of barn wall.

Blinds: The blinds will be a separate room inside the barn

Safety: At all times, the safety of the dogs, handlers, and rats is to be of paramount importance. Rats will be humanely handled, and confined safely in aerated PVC tubes; Barn Hunt is not intended to harm or kill rats.

Crating: We prefer that you crate your dog in your vehicle, but if you need to crate indoors there will be indoor crating space on concrete for quiet dogs.

Leashes and Collars: Electronic collars/devices are not allowed. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed. Dogs may not be brought to the gate in any disallowed

collar. Dogs MUST run "naked," without a collar/harness. Dogs should be brought to the ring with collars/harnesses which can be easily and quickly removed and replaced.

Bitches in season: Are eligible for entry but will be required to be kept separate from all other dogs and will run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until the closing time if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the general briefing.

Refunds: No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, and act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee. Refunds are ONLY allowed if requested before the closing date. Refunds of online entries after acceptance will be refunded minus the 3% online entry fee.

Food: There are fast food restaurants within 15-20 minutes of the trial. There will be lunch and snacks for volunteers and workers.

Payment and Forms: If entering on Secreterrier, payment must be made at the time of entry for the entry to be accepted. If entering on paper, all entry forms are required to have all information completed including the Barn Hunt number, CORRECT NAME, height, signature, etc. Payment must be included with entry. Incomplete forms, nonpayment and returned checks do not constitute a valid entry fee. There is a \$50.00 returned (non-negotiable for any reason) check fee. Entries may be done via our online form or hard copy mailed. No emailed entries accepted.

Awards: Ribbons will be awarded for all qualifiers in the regular classes and the Instinct Test. Ribbons will be awarded for first through fourth place in Novice through Master. Title ribbons will also be provided. Special Awards may also be provided.
