- \*Exhibitors are responsible for complete, accurate, and legible information on the entry forms. Any illegible or incomplete entries will not be entered in the trial.

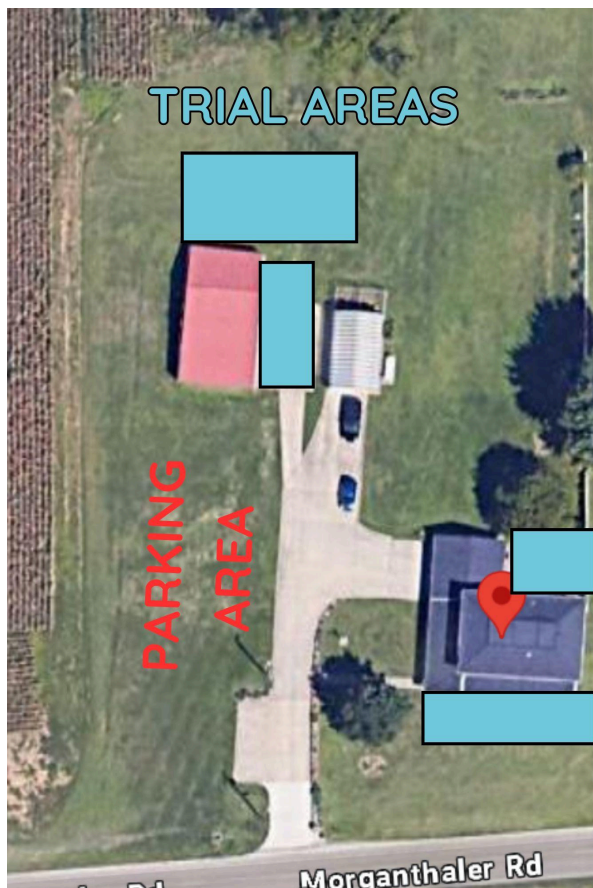

<p><b>From I-74 East</b> - Follow I-74 to New Haven Rd in Harrison. Take exit 1 from I74 3. Merge onto I-74 Entering Ohio. Take exit 1 for New Haven Rd toward Harrison Continue on New Haven Rd. Take OH-128 to Morganthaler Rd in St. Clair Township. Use the left 2 lanes to turn left onto New Haven Rd. Turn left onto OH-128. Continue onto S B St. Turn right onto N B St./Hamilton Eaton Rd Continue to follow Hamilton Eaton Rd. Turn left onto US-127 N/Hamilton Eaton Rd. Turn right onto Jacksonburg Rd. At the traffic circle, take the 1st exit onto Morganthaler Rd. Destination will be on the left.</p> <p><b>From I-74 West</b> - Take I-75 N, I-74/US-52 W, I-275 N and OH-126 W/US-27 N/US Hwy 27 N to OH-128 N in Ross Township.
